

Dear Guest,

according to local regulations, we can only allocate 30% of our rooms to unvaccinated guests from 15th of December 2021 to 31st of January 2022 inclusive. This may lead to a situation where we cannot provide you with a room, even with a confirmed reservation. To avoid this, please inform us in advance about the vaccination status of you and your Covid-19 comrades. Thank you!

MEASURES

Your safety and well-being is really important to us and our colleagues. Therefore we elaborated new standards regarding safety, hygiene and cleanliness against the corona virus.

Specific actions by the hotel

- Masks and disinfectant stations in all pubclic areas for your safety
- Trained staff regarding COVID-19 measures
- Extensive arrangements providing safety distance in all public areas & meeting spaces
- Strict procedures with special disinfectants and increased cleaning frequences will be performed at all public areas, meeting spaces and high touch points
- We serve food & drinks follow to strict hygiene rules during the preparation

QUARANTINE

- 1. Upon arrival from the EU/Schengen area*:
 - When entering Poland, a 10-day quarantine is obligatory, which may be shortened after performing an antigen or molecular test (RT-PCR) no later than 48 hours after crossing the border
 - People with a negative result of the test performed not earlier than 48 hours before crossing the border are exempt from quarantine
 - People vaccinated against COVID-19 with one of the 4 types of vaccines are exempt from quarantine
 (2 doses Pfizer/ Moderna/AstraZeneca and 1 dose Johnson & Johnson). At least 14 days must elapse after the last dose
 of vaccine was received
 - People who completed home isolation, isolation or hospitalization due to infection with SARS-CoV-2 virus, no later than 6 months before the day of crossing the border of the Republic of Poland are exempt from quarantine
 - Children up to the age of 12 are released from quarantine if they travel under the care of vaccinated adults or those with a negative test result within 48 hours before crossing the border

- 2. Upon arrival from outside the Schengen area / from outside the European Union:
 - When entering Poland, a 10-day quarantine is obligatory. (It is not possible to be released from quarantine directly on the basis of a test performed within 48 hours upon arrival in Poland. This possibility is allowed only after 7 days)
 - People vaccinated against COVID-19 with one of the 4 types of vaccines are exempt from quarantine.
 (2 doses Pfizer/ Moderna/AstraZeneca and 1 dose Johnson & Johnson). At least 14 days must elapse after the last dose of vaccine was received
 - People who completed home isolation, isolation or hospitalization due to infection with SARS-CoV-2 virus, no later than 6 months before the day of crossing the border of the Republic of Poland are exempt from quarantine
 - Children up to the age of 12 are released from quarantine if they travel under the care of vaccinated adults or those with a negative test result within 48 hours before crossing the border

PUBLIC SPACE

- Keeping a safe distance
- In resturants and pub we covering the face until we take a seat at the table
- Hand disinfection at the time of entering the restaurants and pub
- Disinfection of the table after the end of serving guests in the premises
- · Disinfect regularly general toilets, elevators, reception desks and other and high touch points
- Use the main elevators for a maximum of two people or together with yours accompanies
- Use the parking elevators for a maximum of one person or together with yours accompanies

CONFERENCE ROOMS

- Social distance of 1,5m between the guests is obligatory for everybody in the meeting room
- The capacity of the meeting rooms are limited to 1 person per 10m² (fully vaccinated guests excluded from these limit)

RIVERVIEW WELLNESS CENTER

- · We recommend disinfecting the gym equipment before and after use
- Compliance with the hygiene rules of users in swimming pools
- We recommend that you keep a safe distance when using the RiverView Wellness Center
